## The COVID 19 Pandemic

We are so glad we added our Drive Up when we did our renovations in 2014 & 2015! We have been able to serve our over 4400 members our regular hours through the worst part of the pandemic by utilizing the drive up, telephone banking, online banking and our after-hours depository. Thank you for your patience during this difficult time.

### Effective 6/22 our lobby reopened with restrictions.

Wear a mask. Use Hand Sanitizer (Provided). Prepare your transaction slips before entering the lobby. (Keep the pen if you use one of our pens). Follow the 6-foot social distancing stickers on the floor. We will be limiting the number of members in the lobby at one time to a maximum of 5.

Appointments are required for loan closings, new account openings, or to meet with a staff member for anything other than processing a transaction.


